1.INTRODUCTION:

In accordance with the Government of India Ayush letter No R-11011/02/2018-EP (IM-I)Part – 1 Dated 21-09-2018 for common counseling, a centralized counseling board of Uttarakhand Ayurved University has been constituted and assigned the task of conducting the UAUC PG-2018 Uttarakhand Ayurved University Centralised counselling for two campus colleges of Uttarakhand Ayurved University and Private Post Graduate Ayurved Colleges affiliated to Uttarakhand Ayurved University recognized by Central Council of Indian Medicine(CCIM), Ministry of AYUSH, GOVT. of India, for the academic session of 2018-19. The Counseling will be conducted on the basis of merit of AIA-PGET -2018 examination and eligibility criteria & other terms and conditions and as per direction received from Ministry of Ayush Govt.of India New Delhi and state Govt. and adopted by the counseling board

Centralized counseling will be conducted for following quota of seats:-

(A). MD/MS(Ayu) Courses in UAU Campus Colleges (Rishikul Campus & Gurukul Campus of UAU) and Private Ayush Colleges Affiliated to Uttarakhand Ayurved University, Central Council of Indian Medicine, Ministry of AYUSH, GOVT. of India

1.1 The registered eligible candidates who have qualified AIA-PGET -2018 will get admission against available State quota seats and All India quota seats / Management quota seats in MD/MS(Ayu) Courses by centralised counseling on merit cum choice basis.

2.GENERAL INSTRUCTIONS, TERMS AND CONDITIONS:

2.1 The applicants are required to fill the application form to register him/her and pay the required registration / counseling fee by ONLINE mode only. The counseling registration fee shall not be refunded under any circumstances.

2.2 The candidates have to complete the online application form in **all respects** and also to upload his/her photograph & signature (same as submitted in AIA-PGET -2018 application form) in the appropriate box (**please go through the flow chart for online application procedure**). The candidates are further advised to re-check the entries/information given by him/her before submitting the same as **there is no option for editing the entries after Final Submission of application form**. After final submission of the form, the candidates are required to take the print of the submitted form (hard copy).

2.3 The candidates are advised to retain the copy of the form submitted to the University for their best Interest for further reference and queries.

2.4 The candidates are advised to keep at least **05 copies** of same photographs (same as submitted in AIA-PGET -2018 application form). The candidates will have to produce the same copy of photographs for entire admission process.

2.5 Depending upon the directions received from time to time by various regulatory bodies like CCIM, Government of India, State Government and Hon'ble Courts, the Schedule/availability of seats/ Rules/Terms & Conditions may be subjected to change. Such information will be notified on the university website www.uau.ac.in only. Candidates must refer the website regularly for any update. No separate intimation will be sent to the candidates.

2.6 Only appearing in the UAUC-PG 2018 Uttarakhand Ayurved University counseling does not confer any right to secure a **MD/MS(Ayu) Courses** seat. The selection and admission to **MD/MS(Ayu)** on a State quota and All India quota seats /Management quota seats in any PG College is subject to fulfilling all the eligibility criteria, state reservation policy, other terms & conditions etc. mentioned in the Information Bulletin and/or amendments made thereafter till the time of counseling.

2.7 Counseling Registration Fee shall neither be carried forward to a future date nor refunded, under any circumstances.

2.8 In case the information provided by the candidate is found wrong in the application form, his/her application will be summarily rejected. If any candidate secures admission in the college/institute by providing wrong information in his/her application, detected later on in due course, his/her admission will be cancelled at the cost and risk of the candidate. **Hence candidates are advised to fill the online application form very carefully and re-check before the final submission.**

2.9 Candidate's eligibility is purely provisional and is subject to the fulfillment of eligibility criteria as prescribed in this Information Bulletin, during subsequent verifications of his/her documents at counseling, admission or afterwards.

2.10 University/counseling board reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in the UAUC-PG- 2018 Centralized Counseling even though he got himself registered and paid the required fee.

2.11 Instructions, Terms & conditions in the Information Bulletin are liable to change based on decisions consciously taken by the UAUC-PG-2018 counselling Board, Ministry of Ayush , Govt. of India and Uttarakhand Government from time to time. There is no equity or any rights that are /or deemed to be arising in favour of candidate.

2.12 The candidate must ensure before filling the application form that he/she fulfils the eligibility requirements for quota of seat he/she is applying for i.e., State or All India quota seats / Management Quota seat. The fee once paid shall not be refunded in the event of rejection of the application. Only eligible candidates will be considered for counseling/admission.

2.13 The candidates are advised to give their complete mailing address, ID proof details and correct contact **telephone/mobile numbers and email** in the application form.

2.14 The records of Counseling shall be preserved only for a period of one year from the date of the counseling.

2.15 All the matters related to counseling, decision of UAUC-PG 2018 Counseling Board and Government of Uttarakhand as the case may be, shall be final and binding to all.

2.16 In case of any ambiguity in interpretation of any of the instructions/ terms /rules/ criteria the determination of eligibility/conduct of counseling/registration of candidate/information contained herein, the interpretation of the UAUC-PG-2018/ Counseling Board as the case may be, will be final and binding.

2.17 Only those candidates who have accepted all the terms & conditions mentioned in the information Bulletin should apply.

3. ELIGIBILITY CRITERIA FOR UAUC-UG-2018 UTTARAKHAND AYURVED UNIVERSITY CENTRALISED COUNSELING

The counseling and admission shall be open to registered candidates only who will fulfill the following criteria:

3.1 For MD/MS(Ayu) Courses in UAU Campus Colleges & Private AYUSH Colleges for State Quota of Seats.

- The candidate must be an Indian National.
- B.A.M.S.Degree from a statutory University recognized by Central Council of Indian Medicine (CCIM), New Delhi India.
- Candidates who are Domicile/Permanent residents of Uttarakhand **and** have passed **BAMS** from a recognized Ayurveda institution situated in the State of Uttarakhand.
- Candidates who are not Domicile/Permanent residents of Uttarakhand but have passed **BAMS** from a recognized Ayurveda institutions situated in the State of Uttarakhand shall also be eligible, **but they will not be entitled for any type of reservation.**
- Candidates who are Domicile/Permanent residents of Uttarakhand but have passed **BAMS** from a recognized Ayurveda institutions situated outside the State of Uttarakhand shall also be eligible.
- The Candidate must have completed minimum 12 months rotatory Compulsory Internship by 31st October, 2018.
- Candidate must be registered with any State Board/Central Council of Indian Medicine (CCIM), New Delhi.
- Candidate must be in common qualifying merit list of AIA-PGET-2018.

Must have fulfilled all the eligibility criteria mentioned in the UAUC-PG-2018 Information bulletin and qualified AIA-PGET -2018 examination that is ***The minimum eligibility marks of the entrance test for admission in the case of general candidates shall be fifty per cent of the total marks in the case of candidates belonging to the schedule castes, the scheduled tribes and regular Central or state Government service candidate shall be forty per cent and in the case of candidates belonging to the other backward classes shall be forty-five per cent***”

The candidate claiming him/her as domicile/permanent resident of Uttarakhand has to produce the domicile/permanent resident certificate issued by the competent authority of the state of Uttarakhand

3.2 For MD/MS(Ayu) Courses in UAU Campus Colleges & Private AYUSH Colleges for ALL INDIA Quota of Seats /Management Quota seats_.

- The candidate must be an Indian National.
- All India/ Management seats are open to all eligible candidates but they will not be entitled for any type of reservation.
- B.A.M.S.Degree from a statutory University recognized by Central Council of Indian Medicine (CCIM), New Delhi India.
- The Candidate must have completed minimum 12 months rotatory Compulsory Internship by 31st October, 2018.

- Candidate must be registered with any State Board/Central Council of Indian Medicine (CCIM), New Delhi.
- Candidate must be in common qualifying merit list of AIA-PGET-2018.
- Must have fulfilled all the eligibility criteria mentioned in the UAUC-PG-2018 Information bulletin and qualified AIA-PGET -2018 examination that is ***The minimum eligibility marks of the entrance test for admission in the case of general candidates shall be fifty per cent of the total marks in the case of candidates belonging to the schedule castes, the scheduled tribes and regular Central or state Government service candidate shall be forty per cent and in the case of candidates belonging to the other backward classes shall be forty-five per cent***

4 RESERVATION POLICY

4.1 Reservation policy will be applicable **college wise** on all seats of **state quota** as per the prevailing rules of Government of Uttarakhand, applicable at the time of counseling. There will be **NO RESERVATION applicable for All India / Management quota**

4.2 Regarding reservation, Government Orders issued from time to time, by the Government of Uttarakhand will be applicable for reservation and the certificate issued by the competent authority of Uttarakhand Government will only be valid.

4.3 Candidates who are domicile/permanent resident of Uttarakhand will be entitled for the benefit of any type of reservation, only if they produce the specific category certificate issued by the competent authority of the State of Uttarakhand.

4.4 Vertical Reservation: 04% seats will be reserved for the candidates of Scheduled Tribes (ST) of Uttarakhand and, 19% seats will be reserved for the candidates of Scheduled Castes (SC) of Uttarakhand and 14% seats will be reserved for Other Backward Classes (OBC) (except prevailing creamy layer criteria as prescribed by the state government) candidates of Uttarakhand. Remaining seats will be treated as unreserved category seats.

4.5 Horizontal Reservation (in each vertical category): 30% seats will be reserved for women candidates, 05% seats will be reserved for the candidates of Defense Personal Ward (DPW) of Uttarakhand. 02% seats will be reserved for dependents of Freedom Fighter (FF) of Uttarakhand in respective category of Vertical reservation.

4.6 For Defense Personnel Wards (DPW) candidates, the certificate issued by the competent authority for this purpose will be valid

4.7 If a candidate is eligible for more than one subcategory reservation then seat allotment will be done in decreasing percentage of subcategories.

4.8 OBC Candidates are advised to check his/her OBC certificate carefully and ensure that it is valid, because the OBC certificate is valid for three years duration only. The OBC certificate should be valid up to the last date of admission for session 2018-19 OR at the time of particular round of counseling and admission in the concerned college / institute claiming candidate for reservation with invalid OBC certificate will be summarily rejected during the counseling and he/she will be considered as UR candidate only

4.9 If category/subcategory seats of "State Quota" remain vacant due to non availability of eligible candidates of their respective categories/subcategories, then these vacant seats will be converted in the last round of counseling as per the prevailing rules of Govt. of Uttarakhand applicable at the time of counseling.

4.10 Candidates who belong to Scheduled Castes/ Scheduled Tribes/Back ward Classes of Uttarakhand have to produce caste certificate and Uttarakhand state domicile/permanent resident certificate issued by the competent authority of the State Government. The original certificate has to be produced at the time of admission. If a candidate fails to produce the original caste certificate and domicile/permanent certificate of Uttarakhand he/she will not be eligible for the benefit of

reservation. The candidate shall be responsible for the same. In case of non-availability of reserve candidates in their respective categories, conversion of seats will be done as per **Govt. of Uttarakhand order no 1070/XXVIII/2017-150 II Cover dated 25th August, 2017**

**4.11 Reservation for persons with disabilities (PWD) candidates **

For persons with disabilities (PWD) candidates who are domicile of Uttarakhand 4% seats of the annual sanctioned state quota (college wise) shall be reserved (horizontal reservation) and filled up by the eligible candidates under persons with disabilities (PWD). **Candidates must have to produce the valid certificate from competent authorities.**

4.12 In case eligible differently abled candidates are not available in its category then the vacant seats shall be filled by other PH candidate in order of merit as per the provision given in government of Uttarakhand order no 1070/XXVIII/2017-150 II Cover dated 25th August, 2017

4.13 In case of non availability of any differently abled candidates in unreserved (PH) category even after conversion as mentioned above the seats will be converted in to open seats in that particular category as below in the last round of the counselling.

Scheduled Tribe (ST) PH => Scheduled Tribe (ST) Open

Scheduled Cast (SC) PH => Scheduled Cast (SC) Open

Other Backward classes (OBC) PH => Other backward classes (OBC) Open

Open / Unreserved category PH => Open / unreserved category

4.14 Reservation policy for Wards of Kashmiri Migrants (WKM)

Online Applications are invited from the wards of Kashmiri Migrant Candidates, who have qualified in AIA-PGET -2018-, for admission to 01 reserved seat. The interested candidate should Produced the following self attested certificates/documents **apart** from the documents mentioned in Para 10.D of this Information Bulletin:

1. Certificate of registration as Kashmiri Migrant issued by the Relief Commissioner, Jammu or competent authority of Uttarakhand to establish the status of the applicant as registered migrant

2. Proof of property in Kashmir of the parent of the candidate. (Scanned documents should be emailed separately on uaucounselling@gmail.com on the day of choice filling. Candidates are requested to submit notarized translated version in English language if the documents are in the language other than Hindi or English

3. Proof of **current residence** (such as Ration Card/Photo Identity Card issued by the election Commissioner /driving license/aadhar card/passport etc.)

Note:-

- 1. Domicile of Uttarakhand is not mandatory in order to get the benefit WKM reserved seats.**
- 2. In case, eligible WKM candidates are not available then the vacant seats will be filled by general category candidates in round 2nd of counseling.**
- 3. The Kashmiri Migrant candidates, who otherwise don't fulfill the eligibility criteria for State Quota Seat, will only be eligible for State Quota Seats reserved for Wards of Kashmiri Migrant and All India-management quota seats.**
- 4. The admission shall be made on the basis of merit in the AIA-PGET -2018 -2018 qualifying examination.**

5- COUNSELLING REGISTRATION FEE

Online counselling registration Fee is Rs- 5,000/- for round 1 and round 2 for all categories and Rs. 2000/- for mopup round for already registered candidates and Rs-5000/- for fresh registration(New Candidate)

5.1 Counseling registration fee shall neither be refunded nor carried forwarded, if the application for UAUC- PG-2018 Centralized counseling is rejected/candidature is found to be ineligible. Hence candidates are advised to read the eligibility criteria carefully before applying. Only eligible candidates will be considered for counseling/admission.

5.2 For First and Second Round Counseling registration fee as described above will have to be paid online through Net Banking, Credit or Debit card only. No cheque or draft will be accepted.

5.3 For MOP- Round counseling, **already registered candidates are required to deposit the registration fee of **Rs. 2000/- only** (by cash or D.D in favor of **FINANCE OFFICER UTTARAKHAND AYURVED UNIVERSITY, PAYBLE AT DEHRADUN**). **Fresh candidates (New Candidates)** are required to deposit Rs-5000/-to get themselves registered (by Cash Or D.D in favor of **FINANCE OFFICER UTTARAKHAND AYURVED UNIVERSITY, PAYBLE AT DEHRADUN**) at the Counselling venue.**

7. STIPEND

1. Stipend will be paid to the PG students of Rishikul Campus (Haridwar), UAU/ Gurukul Campus (Haridwar), UAU as per Uttarakhand Government rules
2. **No stipend will be paid to the candidates selected on Self Financing seats (ALL INDIA QUOTA) In Rishikul Campus (Haridwar), UAU and Gurukul Campus (Haridwar), UAU .**

8- BOND

1. All the admitted scholars after completion of the counseling process have to execute a bond (Notarised affidavit of Rs 100/) to the extent of Rs.2:00 lakh that they will not leave the study before completion of the course, failing which he/she will have to deposit the cost of bond money along with stipend money and their deposited fee will be forfeited.

9. COUNSELLING PROCEDURE

9.1 AIA-PGET -2018 qualified eligible candidates interested to participate in counseling against PG , State/All India-Management quota seats are required to register themselves in various rounds of counselling. **Candidates who fail to register in 1st round of counselling can participate in 2nd and Mop-Up round of counselling after registration and payment of required fee.**

9.2 Only registered candidates will be allowed for that particular round of counseling.

9.3 The candidate is compulsorily required to furnish **AIA-PGET -2018 examination Roll Number, AIA-PGET -2018 application number, valid mobile number and other required information** in order to register for counseling. Candidate will receive a verification code on their registered mobile, which will be used by them for registration in subsequent steps of online filling of application form.

9.4 If candidate failed to lock the filled in choices, the same will be locked automatically as per the time specified in the counseling schedule. If a candidate failed to fill any choice, he/she will not be eligible for seat allotment

9.5 The general instructions for eligible candidates:

- Registration facility is available in each round of counseling as notified in counseling schedule. To become eligible to participate in any particular round of counseling candidate have to register themselves and fill their choices in that particular round of counseling.
- If a candidate has not registered himself in a particular round of counseling, he/she will not be considered for seat allotment for that particular round of counseling.
- As per the directions of Hon'ble Supreme Court of India in W.P. (c) 267/2017 DAR-US-SLAM EDUCATIONAL TRUST and Ors. Vs. MEDICAL COUNCIL OF INDIA and Ors. Dated 09.05.2017. Candidates joined in second round of counseling will not be allowed to vacate seat. **On the similar ground the candidates joined through AIA-PGET -2018 Uttarakhand Ayurved University centralized counseling in second and further rounds of counseling will not be permitted to vacate/resign/surrender the seat.**
- If candidate allotted a seat in 1st Round and even if candidate does not report/join the allotted college he will be eligible for subsequent rounds.
- If a candidate allotted a seat in 2nd round of counseling and once candidate joined the allotted seat would not be eligible for resigning/surrender of joined seat.

- Candidates who have been allotted seat in round I of counseling can opt for seat up gradation in round II of counseling only
- If a candidate has upgraded in the round II the seat allotted in round I gets automatically cancelled and allotted to next eligible candidate in merit. Candidates are advised to select choices carefully.
- Candidates have to fill new/fresh choices in each round of counseling to become eligible for seat allotment in that particular round
- Candidate can give as many choices as he/she wishes during online choice filling. However choices should be in order of candidate's preference & eligibility.
- **Candidates are advised to select the choices very carefully. If candidate is not interested in any specific Quota/College/Course, it is advised not to opt for that specific Quota/College/Course seat in choice filling process as allotment once done will not be altered. University/ Counseling Board will not be responsible for any mistake done at the part of the candidate.**
- Candidate has to fill up the fresh choices/quota for each subsequent rounds of counseling separately irrespective of previous choices/quota.
- **No Candidate will be permitted to vacate his/her admitted /joined seat in second and further round of counseling.**

9.7 UAUC PG-2018 Uttarakhand Ayurved University Centralized counseling will be carried out in the following rounds.

(a) First Round :-

- Candidates have to online register (including payment of required registration) themselves and fill choices as per their preference & eligibility to become eligible for first round of counseling.
- **Candidates must keep a print copy of the online choice filled form for future reference.**
- The College allotment letter will be available online along with necessary instructions in the University website only. The printout of this allotment letter will have to be produced by the candidate at the time of admission to the college allotted. No extension of last date of admission will be permitted.
- **Candidates who are allotted the seats will have to secure admission in the concerned Ayurveda colleges on or before the last date of admission of that particular round otherwise admission stands cancelled automatically.**
- Candidates are required to join allotted institution/college and complete the admission formalities then only candidate can exercise option to participate in second round of counseling for up gradation. For Round 1 candidates can resign from their allotted seat in First Round, if he/she are not satisfied with the allotted seat and can still participate in Round 2 with original User ID & Password of Round 1. Candidates who are allotted a seat in Round 1 but do not join are

also eligible to participate in Round

- 1st Round candidate allotted a seat in 1st Round and even if candidate does not report/join the allotted college he/she will be eligible for subsequent rounds.
- **Candidates who have taken admission against the allotted seats will be permitted for course/college/quota up-gradation up to second round of counseling only.**
- The registered candidate who does not get allotment to any College may participate in the next round of counseling.

(b) Second Round:-

- The following group of candidates are eligible for 2nd Round of allotment:-

Group-I: Registered candidates who did not get any seat allotment in the 1st round.

Group-II: Candidates who have reported at allotted institute during 1st round of allotment and wants to participate for second round up-gradation.

Group- III: Candidates who have been allotted a seat but not Joined.

Group-IV: Candidates who are registering for the first time.

- New/Fresh Candidates have to online register (including payment of required registration) themselves and fill choices as per their preference & eligibility to become eligible for second round of counseling. However **already registered Candidates & candidates opting for seat up gradation have to Online re- registered themselves without payment of registration fee.**
- **Candidates who have admitted against round I allotted seat has a last option to vacate his/her allotted seat online mode before 2nd Counseling After that no candidate will be permitted to vacate/ resign/ surrender his/her admitted seat.**
- All registered candidates have to fill & lock their choices as per their preference order & eligibility.
- The College allotment letter will be available online along with necessary instructions in the University website only. The printout of this allotment letter will have to be produced by the candidate at the time of admission to the college allotted. No extension of last date of admission will be permitted.
- **Candidates who are allotted the seats will have to secure admission in the concerned Ayurved College on or before the last date of admission of that particular round otherwise admission stands cancelled automatically.**

If a candidate allotted a seat in 2nd round of counseling and once candidate joined the allotted seat would not be eligible for vacate/resigning/surrender of joined seat

(c) . Mop Up Round-I (Manual Round)

The Following categories of candidates are eligible for Mop up Round:-

- Candidates who are registering for the first time.
- Candidates who have registered but not allotted seat in Round I & Round II.
- All candidates except those who are holding/joined a seat of Round I or Round II.
- Candidates have to report themselves personally along with required original documents at mop up round of counseling at the designated counseling venue as per schedule.
- To become eligible For MOP- Round counseling, **already registered candidates** are required to deposit the registration fee of Rs.2000/- only (By cash or D.D D in favor of **FINACE OFFICER UTTARAKHAND AYURVED UNIVERSITY, PAYBLE AT DEHRADUN**). **Fresh candidates** (New Candidates) are required to deposit Rs-5000/-to get themselves registered (by Cash Or D.D in favour of **FINACE OFFICER UTTARAKHAND AYURVED UNIVERSITY, PAYBLE AT DEHRADUN**) at the Counselling venue.
- Eligible candidates will have to present him/herself in front of counseling board at the designated counseling venue as per schedule date and time, for seat allotment.
- The choices for Mop-up round will be opted on the spot by the candidates in front of the counseling Board as per their eligibility & available seats.
- The candidate, if allotted any seat, has to secure the admission on the spot at the college counter on the counseling venue by depositing the full amount of tuition fee and original documents. No extension of time will be given under any circumstances

Round specific additional instructions will be displayed separately on University website. Candidates are advised to visit the University website regularly for updates regarding counseling. No personal intimation will be sent.

After doing the above mentioned formalities/procedure, the admission process will only be completed once the candidate gets the admission letter issued by the concerned college within the specified time period mentioned in the allotment letter. Hence, the candidates are required to make necessary arrangement from his/her side well in time to complete the whole admission process within the specified time period of that particular round.

2. FOR UNIVERSITY CAMPUS COLLEGES (RISHIKUL CAMPUS AND GURUKUL CAMPUS)

2.1. If a candidate wants to quit the college allotted to him in the First round he/ she has to inform the counseling Board/ Uttarakhand Ayurved University through the Principal of the concerned college **before the date of registration of second round** that he/she has to vacate the seat allotted to him/her in the counseling & then only he/she will be entitled to get refund of the fees deposited by him/her after deduction of Rs, 4000/-only (as administrative charges). In addition, charges for the services availed (e. g. Hostel, mess etc) by the candidate will also be deducted from the fees deposited, on actual consumption/rational basis, by the college administration

2.2 A candidate if vacates the seat after second round of counseling his/her fees will be forfeited.
